

Annex 7 Geothermal Power Generation Equipment Water Use and Tailwater Reinjection Volume Reporting Form

I. Instructions for Completion

- (I) This reporting form is established pursuant to Paragraph 6, Article 15-3 of the Renewable Energy Development Act.
- (II) Operators of geothermal power generation equipment shall record daily water consumption for power generation, Tailwater Reinjection volume, and other necessary matters, and shall submit quarterly reports to the competent authority and the municipal or county (city) water resources authority for recordation.
- (III)“Quarterly” refers to: January–March as the first quarter; April–June as the second quarter; July–September as the third quarter; and October–December as the fourth quarter.
- (IV) Quarterly reporting forms shall be submitted by the fifteenth day of the month following each quarter. For example, the first-quarter report shall be submitted by April 15 of that year, and so forth. The fourth-quarter report shall be submitted by January 15 of the following year.
- (V) If an operator of geothermal power generation equipment fails to submit the required report within the prescribed period, the case shall be handled in accordance with Paragraph 2, Article 20-1 of the Renewable Energy Development Act.
- (VI) If geothermal hot water and steam are both used simultaneously for power generation, two-phase flow measurement errors shall be avoided. The measurement instruments used for the water-use and Tailwater Reinjection reporting form shall be installed at an appropriate location after the heat exchanger, and the pipeline entering the heat exchanger shall be a single closed line

without any other withdrawals.
